**WHEREAS**, the COUNTY and the UNION mutually agree that the COUNTY is committed to ensuring the safety and protection of the residents and visitors of Hawai'i through the employment and development of highly skilled and qualified Water Safety Officers (WSOs); and

**WHEREAS**, the COUNTY and the UNION further mutually agree that the effectiveness of the Ocean Safety Division is reliant upon the recruitment, training, and promotion of experienced and educated personnel within the department; and

**WHEREAS**, Article 13, Section B.4 of the Unit 15 Collective Bargaining Agreement stipulates that "Other factors being relatively equal, seniority shall prevail" during the promotion process; and

**WHEREAS**, the COUNTY and the UNION recognize that the term "relatively equal" requires clarification and additional criteria to ensure fairness and transparency in the promotional process for WSOs; and

**WHEREAS**, the COUNTY and the UNION acknowledge that incorporating an Experience and Education (E&E) component into the WSO promotional process will better evaluate the qualifications and preparedness of candidates for higher responsibilities;

**NOW, THEREFORE**, the COUNTY and the UNION mutually agree to the following provisions regarding the Experience and Education (E&E) component for WSO promotions:

1. **Effective Date**: This agreement shall be effective on \_\_\_\_\_\_, 2025, and shall apply to all future competitive promotions for Water Safety Officers within the Hawai'i Fire Department.

#### 2. Experience and Education (E&E) Component:

- An Experience and Education (E&E) score shall be incorporated as part of the assessment for all future WSO promotions
- The E&E score will account for 25% of the total promotional assessment score.
- The criteria for the E&E score will be clearly defined and communicated to all candidates as part of the job posting bulletin.
- The E&E score will be weighted against other factors, including performance evaluations and assessment scores, to ensure a comprehensive evaluation of each candidate's suitability for promotion.

#### 3. Seniority Consideration:

- Seniority shall continue to be a factor in promotions, as per Article 13, Section B.4, but shall only prevail when candidates are determined to be equal after considering the E&E score and other assessment components.
- o In the case of a tie in final score, seniority shall prevail.

## 4. Transparency and Documentation:

 All promotional candidates shall receive a breakdown of their total assessment score, including their E&E score, seniority consideration, and any other factors used in the promotion decision.

Except as may be specifically provided herein, this SUPPLEMENTAL AGREEMENT shall be effective on the first day of the pay period following the day and year written above, and shall remain in effect to and including June 30, 2025. This SUPPLEMENTAL AGREEMENT may be amended, modified, or terminated by either party provided thirty (30) days notice is given
